



Contract for Representation and Management Services

Between

SamBoad Sports Agency (hereinafter referred to as "Agency or Agent" and represented by **Samuel Kwame Boadu** and **Eric Asoma** whom both are 50% shareholders and co-owners of the Agency)

And

Introduction

This Agreement is made and entered into on the above date by and between **SamBoad Sports Agency**, an arm under **SamBoad Business Group Ltd** and **SamBoad Football Academy with LeoCay Media having shares in there and a representative**, all registered under the Laws of Ghana legally with its principal office located at Oyarifa School Junction, off the Accra-Aburi Highway and [Athlete's Name], residing at [Athlete's Address].

1. Purpose and Term of Agreement

1.1. Purpose: The Agency agrees to provide comprehensive career management and representation services to the Athlete, as specified in Section 2 of this Agreement. The Agency shall represent, promote, and advise the athlete in connection with the engagement of the Player as a skilled athlete with a professional football club throughout the world.

1.2. Term: This Agreement shall commence on the date first written above and shall continue for a period of five (5) years. The Agreement is subject to review and renewal every two (2) years upon mutual consent of both parties. Term. This Agreement shall begin on the day of signature hereof



by both parties and shall expire on _____ unless renewed by written agreement between the parties.

1.3 **Particularly**, the Agency shall introduce the Player to any football club which might be interested to retain her services, shall then negotiate on behalf of the athlete the relevant player contract to be signed by the Player and the Club and will subsequently liaise and deal in the Player's interest with the club on all matters of interest for the Player in connection with her engagement with the club.

1.4 In performing these services, the Agency is the Athlete's delegated representative and is acting in a fiduciary capacity on behalf of the Athlete. In no event shall the Agency have the authority to bind or commit the Player in any manner without the express prior consent of the Player

1.5 The athlete will not be allowed to use other Agents or agency as well (restated: this is an exclusive agreement); however, if the Agency gets the player a club/offer, and the player is requested to move up to a higher level, the Agency will then have the player represented by an Agent or agency that is certified with the governing body, this new Agent or agency expects to be then paid off as part of the agreement and not to manage the said athlete within the 5 years commitment years. Unless Player wants to stay with the new agent or agency, where the new Agent or agency will negotiate a fee to settle SamBoad Sports Agency

1.6 The parties agree that their relationship under this contract, in particular their respective rights and duties shall be patterned and governed according to the FIFA Agency and the Laws of Ghana.

2. Services Provided by the Agency

The Agency agrees to provide the following services to the Athlete:

- 2.1. Career Management and Representation
- 2.2. Sponsorship and Endorsements
- 2.3. Media Relations and Publicity
- 2.4. Financial Management and Planning



- 2.5. Legal Support and Compliance
- 2.6. Health and Wellness Support
- 2.7. Educational and Personal Development
- 2.8. Advocacy and Promotion of Women's Sports
- 2.9. General Women's Sports Management
- 2.10. Transfer Representation
- 2.11. Emotional Support
- 2.12. Marketing and Sports Management
- 2.13. Agent Services
- 2.14. Marketing Opportunities

Elaborated Services by SamBoad Sports Agency

2.15 Agency will attempt to obtain Player game film and past Player statistics (with assistance of Player) where Player played in previous recognized teams, professional league, or association football.

2.16 Agency will then create a Player profile linked to Player game film to present to clubs or professional football teams to procure a contract between the Player and a club or team. Agency retains ownership of all profiles. Agency will place these profiles on the Agency website or all social media handles.

2.17 Agency will actively promote Player to clubs and teams worldwide. Agency will then secure an offer and negotiate contract between the club or team and the Player and present the offer and/or contract to the Player for acceptance.

2.18 Agency will obtain travel information, living arrangement information, any financial requirements such as league dues or fees if any, and any other transitional requirements the Player will experience involving her travel and living requirements when relocating to play for a



club or team the Player has contracted with or is about to contract with outside the Republic of Ghana or any other country.

3. Compensation

3.1 For any contract procured by the Agency and signed by the Player, the Agency shall receive a fee of not less than **6% to 10%** as compensation to be agreed with the player, which includes salary and signing bonuses received by the Player from any contract entered into with any professional football club throughout the world and earnings from all other deals facilitated by the Agency, including but not limited to sponsorships, endorsements, and media engagements. This may be waived only by the Agency itself.

3.2 The Agency shall not be entitled to reimbursement of any expenses unless otherwise agreed to in writing. The Agency's services in this instance are set forth in the services listed in this contract.

3.3 In negotiating the Player's contract with a club, the Agency shall include a clause according to which the Agency receives any sign on fee directly from the club. All fees shall be earned and due at the time of execution of any contract entered into by Player.

3.4 Player shall direct the club or other organization that is party to any contract with Player to make payment of any sign on fees directly to the Agency at the time of execution of any contract.

3.1. Percentage Fees: The Athlete agrees to pay the Agency the following percentages of earnings from deals facilitated by the Agency:

4. Responsibilities of the Athlete

4.1 Pending the procurement of a Player contract, Player agrees to timely inform Agency in writing as to any injury or situation which may interfere with Player's ability to contract with a club for professional athletic services. Player specifically agrees to immediately inform the Agency in writing of all past, current, or future legal issues, which the Player may have, or could possibly have on her, record that could directly affect the Player's ability to enter a foreign country to honor a contract.



4.2 Pending the procurement of a Player contract, Player agrees to stay in good physical condition allowing her to perform professional athletic services for a club in the performance of a contract to provide such services.

4.3 Pending the procurement of a Player contract, Player agrees to keep the Agency informed of any change of address or contact number. Player specifically agrees to provide the Agency with a good telephone number where the Agency can contact the player on short notice if need be. Player agrees to make herself available at short notice to the Agency in procuring a contract with a club.

4.4 Player specifically agrees not to contact any club, sports agent, sports agency, scout, or any club for the purposes of seeking a contract for the Player to perform athletic services as a player without written consent from the Agency. Player specifically agrees to immediately inform the Agency should anyone approach, contact, or speak with the Player concerning recruiting the Player for athletic services. Player agrees to allow the Agency to handle all aspect of procuring a contract between a club and the Player or third party agent(s).

4.5 After Player signs with a club, Player agrees to give best services and loyalty to the club, to participate in all club games and practice, training sessions, to provide club with prompt notice of any injury, illness etc. and to comply with contract between club and Player.

4.6. The Athlete agrees to actively participate in and cooperate with the Agency's efforts to manage and promote her career.

4.7. The Athlete shall inform the Agency promptly of any inquiries or offers regarding professional, endorsement, social activities opportunities.

5. Parental Consent (If Athlete is Under 18)

This section is applicable if the Athlete is a minor at the time of signing this Agreement.

5.1. Consent: The Athlete's parent(s) or legal guardian(s) hereby consent to this Agreement and agree to ensure that the Athlete abides by its terms.

6. Renewal and Termination

6.1. **Renewal:** This Agreement may be renewed every two (2) years upon mutual agreement.

6.2. **Termination:** Either party may terminate this Agreement with ninety (30) days written notice. The Agency will still be entitled to the percentages outlined in Section 3 for deals concluded before the termination date.

6.3 Termination of this contract may be made by any of the parties (Player or Agency) at any time by giving a thirty (30) day written notice to the other party and ensuring delivery of the notice by certified mail or by personal service. This notice may be sent by email and confirmation of receipt by the served party will suffice as served and received.

6.4 If the Player chooses to terminate this contract, Player may not obtain a contract with any team or club the Agency has contacted, exposed or communicated to about the Player for 90 days after the 30-day termination date of this agreement.

6.5 Player cannot sign for another club within 90 days after the 30 —day termination of this agreement. If the Player obtains a contract by any such terms aforementioned Agency is entitled to 30% of any Fees the said team or club would have paid if the Agency had secured the contract for the Player.

6.6 SamBoad Sports Agency will allow termination of contracts with any of its signed athletes as the purposes of the termination is not to circumvent the Agency's efforts in securing employment for the Player underhanded, improper, or unethical means. Player will have to pay a compensation fee to be agreed by the Agency if Player decides to terminate this Contract.

- **Arbitration**

Any issue arising out of or in connection to this Agreement shall first be attempted to be settled by Arbitration



- **Applicable Law**

This Agreement shall be subject to the laws of the FIFA Agency regulations, except for the provisions of private international law.

7. Miscellaneous

7.1. **Confidentiality:** Both parties agree to maintain confidentiality of the contents of the Agreement and any matters related thereto including any addendums or pre-contract applications

7.2. **Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of Ghana or any part of the world.

7.3. **Entire Agreement:** This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings. Any amendments and/or additions to this Agreement shall be made in writing.

7.4. **Amendments:** Any amendments to this Agreement must be made in writing and signed by both parties.

7.5 The foregoing, and amendments hereto, is the complete agreement between the parties unless agreed to later in writing by the parties.

7.6 All parties hereto agree and consent to facsimile signatures in signing of this contract.
